

## **Objective of Privacy Policy.**

The objective of this Privacy Policy is to provide an explanation of the rules governing the processing of your personal data and a review of your fundamental rights pertaining the processing of your personal data by **Osorno Media** (further „Osorno Media”).

## **Personal Data Controller.**

Osorno Media sp. z o.o with its registered office in **Edwarda Stachury 4 st., 01 - 684 Warsaw, POLAND** (hereinafter referred to as the ‘Controller’ or ‘Company’) is the Personal Data Controller of your personal data. The personal data collected by the Controller are processed pursuant to the principles specified in relevant regulations on the protection of personal data, including the principles laid down in Regulation (EU) No 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and of the free movement of such data and repealing Directive 95/46/EC (the general data protection regulation) (hereinafter referred to as ‘GDPR’) and local regulations issued in connection with GDPR.

As part of the implementation of personal data protection in our organization, we have decided not to appoint a personal data protection officer due to the fact that in our situation it is not mandatory.

## **Purposes and Legal Grounds for Data Processing.**

Within the scope of its activity and purposes of processing, the Controller shall collect and process following personal data:

- name and surname
- email address

The aforementioned data shall be processed on following legal basis:

1. you have given consent to the processing of your personal data for one or more specific purposes (legal basis: art. 6 point 1 letter a of GDPR), which is particularly sending newsletter and providing data for Partners;
2. for the performance of a contract to which you are a party or in order to take steps at your request prior to entering into a contract (legal basis: art. 6 point 1 letter b of GDPR), which is particularly providing audio service of BibliaAudio Superproduction by electronic means;

2. for the purposes of the legitimate interests pursued by the Company as a controller of data (legal basis: article 6 point 1 letter f of GDPR), which is particularly: serving marketing purposes relating to the services provided by the Company, the purpose of providing information on events or activity of the Company included; serving analytical and statistical purposes, as well as those intended to ensure the cybersecurity relating to the Company's website,

3. in order to process the personal data for compliance with any legal obligations to which the Controller is subject (legal basis: article 6 point 1 letter c of the GDPR).

### **Rights under the Provisions of GDPR.**

Personal data are provided voluntarily. However, depending on specific circumstances, the refusal to provide one's data or requesting their removal may enable the Controller: contacting you, providing you the newsletter or with information on events and activity of the Company, as well as from performing a service.

You should remember your rights in connection with the processing of your personal data referred to in the GDPR, which are:

the right to request access to your own personal data, which also includes the right to receive free copies of your own data (for any subsequent Controller may charge a reasonable fee based on administrative costs for the copies requested);

the right to rectify personal data (if it is incorrect), which also includes supplementing incomplete personal data, but for this purpose we may ask you to provide an additional statement;

the right to delete personal data (the so-called "right to be forgotten"), when, for example, they are not necessary to achieve the purposes for which they were collected, consent to their processing has been withdrawn, or there are no other legal grounds for their processing;

the right to limit data processing, e.g. when you question the correctness of personal data - for a period enabling Controller to check the correctness of this data;

the right to object to the processing;

the right to transfer data, including receiving from Controller in a structured, commonly used machine-readable format your own personal data that you provided to the Controller;

the right to withdraw your consent to data processing (whereby the withdrawal of consent does not affect the lawfulness of the processing that was carried out on the basis of the consent given before its withdrawal);

the right to lodge a complaint to the President of the Office for Personal Data Protection, if you find that the processing of personal data violates the provisions of the GDPR.

## **Period of Processing.**

Depending on specific purposes and legal bases applied to the processing, your personal data shall be particularly processed:

- 1) until the expiry of the limitation periods pertaining to the contract related to the processing of personal data;
- 2) until relevant and legitimate interests related to the processing of specific data and carried out by the Company as the data controller are executed;
- 3) until the expiry of limitation periods pertaining to particular obligations arising from the legislation;
- 4) until an objection is notified or the withdrawal of one's consent relating to the scope of the processing of one's data for marketing or newsletter purposes is made.

## **Transfer of Personal Data to other Entities.**

Your personal data shall only be transferred to entities authorized under the relevant provisions of law or on the basis of an entrustment agreement conducted by the Controller with Processor. The Controller is entitled to entrust the data to entities that are directly or indirectly related to the Company (particularly by organizational or personal links), having their seats in one of the Member States of the European Union.

Furthermore, state authorities and services may also be recipients of your personal data, as well as external service providers (including IT, accounting and legal services, chartered accountants and auditors). The above-mentioned service providers shall unconditionally observe the confidentiality of your personal data and process them in conformity with the provisions applying to the protection of personal data.

We also may transfer you personal data to our Partners, which are:

Acceptance of the Privacy Policy shall be treated as an acceptance for transferring your data to aforementioned Partners.

## **Processing Area. Absence of Profiling.**

Your personal data shall be processed at the Company's registered office and shall not be transferred to any countries situated outside the European Union. In the event of a transfer of personal data to any third countries (located outside the EU), the Controller shall apply appropriate instruments aimed at ensuring the security of your data.

Your personal data shall not be subject to profiling, nor are they to be subject to any other form of automated decision-making.

## **Cookies**

Cookies are small text files that are placed on your computer by websites that you visit. That includes our website. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.
